**FINAL ORDER  
APPROVING THE APPLICATION OF  
DEVON ENERGY PRODUCTION COMPANY, LP.  
FOR INCREASED GAS-OIL RATIO AUTHORITY FOR THE  
RUNNING W (WICHITA ALBANY) FIELD, AND  
FOR ITS MCKNIGHT LEASE, WELL NOS. 192 AND 193,  
SAND HILLS (TUBB) FIELD  
CRANE COUNTY, TEXAS**

The Commission finds that after statutory notice in the above-numbered docket heard on January 4, 2002, the presiding examiner has made and filed a report and recommendation containing findings of fact and conclusions of law, for which service was not required; that the proposed application is in compliance with all statutory requirements; and that this proceeding was duly submitted to the Railroad Commission of Texas at conference held in its offices in Austin, Texas.

The Commission, after review and due consideration of the examiner's report and recommendation, the findings of fact and conclusions of law contained therein, adopts as its own the findings of fact and conclusions of law contained therein, and incorporates said findings of fact and conclusions of law as if fully set out and separately stated herein.

It is furthered **ORDERED** by the Railroad Commission of Texas that all oil wells in the Running W (Wichita Albany) Field, Crane County, Texas, be and are hereby granted permission to produce under increased net gas-oil ratio authority, with a daily gas limit of 650 MCF.

Therefore, it is **ORDERED** by the Railroad Commission of Texas that Devon Energy Production Company, L.P., be and is hereby granted permission to produce its McKnight Lease Well No. 192 in the Sand Hills (Tubb) Field, Crane County, Texas, under increased gas-oil ratio authority, with a daily gas limit of 580 MCF; and its McKnight Lease, Well No. 193 in the Sand Hills (Tubb) Field, Crane County, Texas under increased gas oil ratio authority with a daily gas unit of 90 MCF.

It is further **ORDERED** that all gas overproduction for the Devon Energy Production Company, L.P., McKnight Lease Well Nos. 192 and 193 in the Sand Hills (Tubb) Field, Crane County, Texas, be and is hereby canceled. All gas overproduction for the Devon Energy Production Company L.P., McKnight Lease Well Nos. 183 and 197 be and is hereby canceled.
