For purposes of this Texas No. 113. [W] <u>4.3.0</u> or subsequent reissues thereof, the following definition is changed from Item 1 (Definitions) of NuStar Texas No. 112. [W] <u>4.3.0</u>:

"Carrier" shall mean (a) ExxonMobil, while a Shipper's Products are being transported on ExxonMobil's portion of the joint movement specified herein, and (b) NuStar, while a Shipper's Products are being transported on NuStar's portion of the joint movement, except that "Carrier" shall mean NuStar with respect to Item 4, Item 9, and Item 12.
