As of December 31, 2022, a total of 542 wells have been physically plugged, though not all of them have yet been invoiced and approved for payment.






State Managed Well Plugging Program Monthly Wells Plugged December 2022



State Managed Well Plugging Program Monthly Cost of Wells Plugged December 2022




State Managed Well Plugging Program Cumulative Wells Plugged December 2022





State Managed Well Plugging Program Monthly Salvage Operations December 2022




