**NOTES**

(1) Natural Gas Liquids delivered to Carrier that have an Ethane content of less than 20% will be assessed a Low Ethane Surcharge of [I] 1.50 Cents per Gallon.<sup>(2)</sup>

(2) The rates herein are subject to increase each July 1, in accordance with the mechanism set forth in FERC regulation 18 C.F.R. § 342.3 or any successor thereto; provided, that if the indexing policy would decrease the then current rate, it shall not apply and said rate shall not be decreased.

(3) A rate of [I] 2.91 Cents per Gallon will be charged when gathering service is performed from the Culberson County Lateral to the West Texas Zone ("Culberson Gathering Fee")<sup>(2)</sup>, except as follows:

- a. During the Month when the total volumes delivered at a single Receipt Point into the Culberson County Lateral exceed 30,000 Barrels per Day (averaged over the course of a Month) ("Incentive Receipt Point"), the rate for gathering service for volumes in excess of 30,000 Barrels per Day (averaged over the course of a Month) at the Incentive Receipt Point will be the Culberson Gathering Fee less [U] 0.5 Cents per Gallon. To the extent there is more than one Shipper at the Incentive Receipt Point, volumes in excess of 30,000 Barrels per Day will be allocated to such Shippers pro rata based upon volumes at the Incentive Receipt Point.

- b. During the Month when the total volumes delivered by an individual Volume Commitment Incentive Program Shipper at any or all Receipt Points into the Culberson County Lateral exceed 20,000 Barrels per Day (averaged over the course of a Month), the Culberson Gathering Fee for volumes in excess of 20,000 Barrels per Day (averaged over the course of a Month) will be [U] 0.0 Cents per Gallon as to such individual Volume Commitment Incentive Program Shipper only. The minimum barrel requirement set forth herein may be adjusted by Carrier at any time. On July 31, 2023, this reduction in rate will automatically expire.
- c. In no event shall the applications of provision a. or b. above cause the Culberson Gathering Fee be less than 0.0 Cents per Gallon.

(4) A rate of [I] 0.52 Cents per Gallon will be charged when gathering service is performed from the Lucid Big Lake Lateral (Crockett County, TX) to the West Texas Zone.<sup>(2)</sup>

(5) A rate of [I] 0.73 Cents per Gallon will be charged when gathering service is performed from the Silver Oak Plant (Bee County, TX) or the Lone Star Gas Plant (Bee County, TX) to the Gulf Coast Zone.<sup>(2)</sup>

(6) A rate of [I] 4.10 Cents per Gallon will be charged when gathering service is performed from the Nueces County Lateral (Nueces County, TX to Live Oak County, TX) to the Gulf Coast Zone (“Nueces Gathering Fee”).<sup>(2)</sup>

- a. Incentive Rate – Minimum Aggregate Volume: For shipments originating from the FHR West Plant on the Nueces County Lateral with a minimum volume commitment to Carrier of 34,000,000 Barrels over an eight-year period, the Nueces Gathering Fee will be reduced by [U] 1.00 Cents per Gallon upon the earlier of
  - (i) eight years after the commitment term commenced or
  - (ii) Carrier’s receipt of 34,000,000 Barrels from the FHR West Plant on the Nueces County Lateral.
