AGREED ORDER OF DISMISSAL WITH PREJUDICE


As reflected by the signatures of their counsel, below, Complainant EXCO Operating Company, LP (“EXCO”) and Respondents Williams MLP Operating, LLC and Mockingbird Midstream Gas Services, LLC (collectively, “Williams”) have requested that the Administrative Law Judge dismiss with prejudice all of EXCO’s claims in this docket. In accordance with their request:

It is ORDERED, ADJUDGED, and DECREED that all claims, causes of action, and requested relief that have been asserted or that could have been asserted in this docket by EXCO against Williams, all as more fully described in the pleadings on file, be and are hereby DISMISSED WITH PREJUDICE.

It is further ORDERED that EXCO will bear its own costs.

This Order disposes of all causes of actions asserted in this docket by EXCO. However, it does not affect the claims, causes of action, and requested relief asserted by CNOOC Energy USA, LLC in this docket or Williams’ pending motion to dismiss CNOOC’s claims in this docket. Docket No. 10856 remains abated.
