Note 1: The “Committed Rate” applies to any Committed Shipper that has an effective Throughput and Deficiency Agreement with Carrier.

Note 2: The “Uncommitted Rate” applies to any shipments by a Shipper that is not a Committed Shipper.

Note 3: In addition to the transportation charge, all barrels received at the Taft Junction, San Patricio County, Texas Origin Point from Gray Oak Pipeline, LLC shall be assessed a pump-over fee of [U] \$0.1162 per barrel.

Note 4: The “Temporary Uncommitted Rate” applies to the first properly received and accepted nomination from any Shipper in a given month for a minimum of 60,000 barrels and a maximum of [W] 150,000 ~~80,000~~ barrels of Product, originating at the Taft Junction, San Patricio County, Texas, via Gray Oak Pipeline, LLC Origin Point. Product transported under this Temporary Uncommitted Rate will not count towards any minimum volume commitment or revenue commitment under any Throughput and Deficiency Agreement or any other agreement.
