TRANSPORTATION RATES

The rates set forth herein apply to the intrastate transportation of Ethylene (as defined in the Rules and Regulations Tariff) by the Ethylene Pipeline from established Origin Point facilities to established Delivery Point facilities at points named below. 3. Delivery Points include the following: (A) GCGV interconnection near Gregory, San Patricio County, Texas; (B) Storage interconnection near Markham, Matagorda County, Texas; and (C) LBI interconnection near Gregory, San Patricio County, Texas.
4. Carrier reserves the right to increase, effective July 1 of each Year, the then current: (a) Priority Status 2 Transportation Rate and/or (b) Uncommitted Transportation Rate, to reflect an inflation adjustment determined as the annual percentage change in the Consumer Price Index – All Urban Consumers, as published each Year by the United States Bureau of Labor Statistics.
