(1) Provided there are sufficient offsetting nominations, service from Midland Station to Goldsmith Station, Texas may be provided through displacement.

Pumpover Charge:

1. The carrier will not assess a pumpover charge for receipts of Crude Petroleum from connecting carriers at Midland Station, Midland County, Texas.
2. Where pumping service is performed by Plains Pipeline, L.P., an additional charge of **[N]** 12.24 cents per barrel will be made on all crude petroleum pumped to connecting carriers or facilities.

Exceptions to Plains Pipeline, L.P.'s Rules and Regulations Tariff:

Rules 25(c) and 25(d) - In lieu of the nomination due date contained in Rules 25(c) and 25(d) of Plains Pipeline, L.P.'s Rules and Regulations Tariff, the following will apply: nominations to the Carrier shall be made before 12:00 noon Central Standard Time/Central Daylight Saving Time, whichever is applicable, on the fifteenth (15th) of the month preceding the movement, as adjusted for weekends and Carrier Holidays pursuant to Rules 25(c) and 25(d).

Rule 80 - In lieu of the 0.2% loss allowance deduction stated in Rule 80 of Plains Pipeline, L.P.'s Rules and Regulations Tariff, the following loss allowance deduction will apply: no loss allowance.
