TEXAS SYSTEM

Except as otherwise expressly provided herein, the rates published in this tariff and the services hereunder are governed by the Rules and Regulations published in Magellan Pipeline Company, L.P. Texas No. 49.14.0, supplements thereto or successive issues thereof with respect to that portion of the transportation services provided by Magellan Pipeline Company, L.P. and KPL South Texas, LLC's Texas No. 62.0.0, supplements thereto and reissues thereof, with respect to that portion of the transportation services provided by KPL South Texas, LLC, (respectively, the "Magellan Rules" and the "KPL Rules"). Any conflicts between the terms of the Magellan Rules and the KPL Rules with respect to the entirety of the joint pipeline transportation governed by the Tariff shall be resolved in favor of the governed by the applicable provision of the Magellan Rules.

Exception to Magellan's Texas No. 49.14.0, Item 30 – Volume Correction and Tender Deductions: Section B. A tender deduction of one-twentieth (1/20) of one percent (1%) by volume will be made on the quantity of Petroleum Products accepted for transported from Waco, TX –Flint Hills Resources, L.P. Terminal (McLennan County) to Dallas, (Dallas County).

Rates in cents per barrel of 42 United States Gallons each.
