Such transportation and pump-over service shall be provided in accordance with the Crude Petroleum product specifications applicable hereto.

**H2S TREATMENT:** If Crude Petroleum received by Carrier contains a level of hydrogen sulfide ("H2S") that exceeds the H2S specification of connecting carriers at the destination points set forth herein, Carrier reserves the right to treat such crude to ensure that it conforms to H2S specifications of connecting carriers. If Carrier performs such treatment, Carrier reserves the right to bill and Shipper shall pay the costs incurred by Carrier as a result of such treatment or removal of H2S.
