<u>Rule 80 Deductions:</u> In lieu of the 0.2% loss allowance deduction stated in Rule 80 of the Rules and Regulations Tariff, the following loss allowance deduction will apply: no loss allowance.

[N] Rule 40 Quality: Solely for purposes of West Texas Sour (WTS) grade Crude Petroleum, the Carrier's reservation of the right to reject Crude Petroleum exceeding the mercaptan limitations or to assess a mercaptan related fee as set forth in Rule 40A of the Rules and Regulations Tariff shall only apply to WTS grade Crude Petroleum received for transportation services under this tariff that is in excess of 2000 parts per million.
