**Unloading Charges:** All shipments unloaded from tank trucks into Carrier's trunk line facilities will be subject to a charge of [I] fifteen and sixty-one hundredths cents (15.61¢) per barrel. All shipments unloaded from tank trucks into Carrier's gathering facilities will be subject to the applicable gathering charge for said gathering facility. Such charges will be in addition to trunk transportation rates published in applicable tariffs.

**Gathering Rate:** When service is performed by Carrier, the rate in ETP Crude LLC's Tariff TX No. 9.3.0, supplements thereto, and successive issues thereof, for the specific origin will apply.

**Exception to Item 40, TX No. 5.0.0, Measurement, Testing, Volume Corrections and Deductions:**  
Crude Petroleum quantities transported originating at Blewitt, TX may be adjusted to allow for inherent losses, including but not limited to shrinkage, evaporation, interface losses, and normal "over and short" losses.
