

EXHIBIT "A" METES AND BOUNDS DESCRIPTION 35 Acre Tract, Nueces County

Fieldnotes for a 35 acre tract of land, more or less, out of Lot 15, of the George H. Paul Subdivision of the Driscoll Ranch (Map D) as recorded in Volume 2, Page 34, in the Map Records of Nucces County, Texas same being out of that 79.557 acre tract conveyed by the Robstown Area Development Commission, a Texas Corporation, unto The County of Nucces as recorded in Document No. 2002043558 in the Official Public Records of Nucces County, Texas and more fully described as follows:

Beginning at a point on the east line of Lot 15 and the west line of Lot 14 of said George H. Paul Subdivision of the Driscoll Ranch and the southeast right of way line of U.S. Highway 77 for the northern most corner of this 35 acre tract, from whence the northeast corner of Lot 15 bears North 00° 13' 30" East 1142.12 feet.

Thence South 00° 13' 30" West along the common lot line of Lots 14 and 15 a distance of 1826.39 feet to a point for corner on the north right of way line of Terry Shamsie Boulevard for the southeast corner of this 35 acre tract;

Thence North 89° 45' 43" West along the north right of way line of Terry Shamsie Boulevard a distance of 1132.43 feet to a point for corner of this 35 acre tract;

Thence North 68° 49' 29" West along the north right of way line of Terry Shamsie Boulevard a distance of 315.37 feet to a point for corner of this 35 acre tract;

Thence North 22° 52' 20" West along the north right of way line of Terry Shamsie Boulevard a distance of 68.51 feet to a point for corner on the southeast right of way line of U. S. Highway 77 for the southwest corner of this 35 acre tract and point of curvature for a circular curve to the right;

Thence along said circular curve to the right, having a central angle of 20° 24' 48" a radius of 1692.98 fect a tangent distance of 304.82 feet and a arc length of 603.18 feet, to a point on the southeast right of way of U. S. Highway 77;

Thence North 44° 21' 33" East along the southeast right of way of U. S. Highway 77 a distance of 1558.52 feet to a point and point of curvature for a circular curve to the right;

Thence along said curve to the right, having a central angle of 01° 14′ 10" a radius of 2216.25 feet a tangent distance of 24.11 feet and a arc length of 47.81 feet, to the Point of Beginning of this tract containing in all 35 acres, more or less.
