**Rule 110A** — In addition to the provisions set forth in Rule 110A, when shipments are unloaded from tank truck into the facilities of Plains Pipeline, L.P., a charge of **[C]** 12.65 cents per barrel will be made in addition to the transportation rates contained herein.
