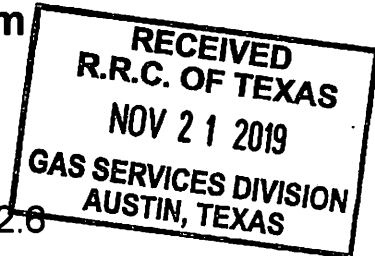

BASE FIXED RATE AND BASE VARIABLE RATE FOR VOLUMES SHIPPED UP TO 10,000 BPD

ESCALATION METHODOLOGY

The General Service Rate shown above shall be adjusted with the Consumer Price Index effective as of each July 1, beginning on January 1, 2020, by the percentage change since June 2019, in the National Consumer Price Index for All Urban Consumers, or its most comparable successor. Notwithstanding the foregoing, the fee(s) shall never decrease, as a result of the foregoing adjustments, below the amounts set forth above. Interest will be due on payments not made when due, as provided in Special Rule 17 of the Rules and Regulations Tariff. The Base Fixed Rate shall not be escalated under this section.
