**Note 1:** The Committed Rates are available to any Shipper for the transportation of Ethane from the Receipt Point to the Delivery Point making a “ship or pay” annual minimum volume commitment greater than or equal to 75,000 Barrels per Day per 12 Month period (the “**Annual Minimum Volume Commitment**”)

for a term greater than or equal to 10 contract years pursuant to and subject to the terms and conditions of a fully executed TSA with Carrier entered into on or before February 1, 2018. The applicable deficiency fees will be set forth in the TSA.

**Note 2:** Each year under this program commences on the first day of a contract year pursuant to a fully executed TSA with Carrier, with the rates governing being based on the period during which the delivery is made. The “**Tier One Annual Commitment**” means: (i) with respect to the first 10 contract years, 55,000 multiplied by the number of calendar days in such contract year; and (ii) with respect to each contract year thereafter 45,000 multiplied by the number of calendar days in such contract year.

**Note 3:** Unless otherwise provided in a fully executed TSA with Carrier, rates are subject to automatic increase each July 1 by multiplying the then current rate by the PPI Escalator (as defined below), rounded to the nearest hundredths of a cent; provided, however, that in no event shall a fee ever be decreased, accordingly no such calculation will be made for any year when the PPI Escalator would have the effect of decreasing the fees. “**PPI Escalator**” means the sum of (a) one, plus (b) a fraction the numerator of which is the PPI (as defined below) for the latest available month that is no longer subject to revision prior to the date on which the adjustment is being made, and the denominator of which is the PPI (using the same base month) for the corresponding month in the preceding calendar year; provided however, that in no event shall the adjusted Transportation Fees for any year be less than the Transportation Fees for the prior year. “PPI” shall mean the Producer Price Index for Industrial Commodities less Fuels (WPU03T15M05). Should the PPI be discontinued, it will be replaced by the index specified by the applicable publisher to be the replacement index therefor, or, if no replacement index is specified by the applicable publisher, the Carrier shall determine a replacement index which uses a reasonably similar calculation methodology as determined in Carrier’s sole discretion.
