UNLOADING CHARGES: All shipments unloaded from tank trucks into Carrier's trunk line facilities will be subject to a charge of **[I] fourteen and six-tenths cents (14.6¢)** per barrel. All shipments unloaded from tank trucks into Carrier's gathering facilities will be subject to the applicable gathering charge for said gathering facility. Such charges will be in addition to trunk transportation rates published in applicable tariffs.

NOTE: The following applies only to referenced origins and destinations as indicated on schedule.

- (1) No deduction will be charged for evaporation and loss during transportation on barrels delivered to this origin from other ETP Crude LLC segments.
- (2) Exception to Item 40, TX No. 5.0.0, Measurement, Testing, Volume Corrections and Deductions A deduction of one-eighth of one percent (0.125%) will be made for evaporation and loss during transportation for all Crude Petroleum with an API gravity below fifty degrees (50°).
- (3) Quality exception applies only to segregated movements of Condensate to Nederland (ETNT Nederland Terminal). Exception to Item No. 25, TX No. 5.0.0, Specification Required as to Quality:
 - a. Gravity cannot exceed 60 degrees API nor be less than 45 degrees API.
 - b. Sulfur shall not exceed 0.2% by weight.
 - c. True Vapor Pressure at actual temperature cannot exceed 10.9 psi.
- (4) Storage and terminalling services are not provided under this schedule at ETNT Nederland Terminal.
- (5) Routing is directly to Sour Lake.
- (6) ROUTING: Routing applies to movements on all ETP Crude LLC's pipelines other than the Nederland, Texas to Longview, Texas 12" pipeline.
- (7) Barrels transported or received from Oyster Bayou Field in Chambers County, Texas are governed by this rate.

Movements will only be made when operating conditions permit and operating capacity is available.
