No. 3.2, supplements thereto and successive issues thereof, and are subject to change, without notice, except as otherwise provided by law.

LINE REVERSAL

The pre-dominate direction of the pipeline is from south to north. However, at the sole discretion of P66 Carrier, when operating conditions permit, P66 Carrier will move Crude Petroleum from origin stations located between Odessa Station and Phillips, Texas to Odessa Station at a charge of [I] 109.05 cents per barrel for the first 450,000 barrels per month, and [I] 65.07 CPB for all reversal barrels greater than 450,000 barrels shipped in a calendar month.

GATHERING CHARGES

When gathering service is performed at point of origin, a charge will be made as provided under "GATHERING CHARGES" in the rate table above, and shall be in addition to the charges for transportation.

Exception to Rule 9 of Amended Rule 71(A), State of Texas

GAUGING, TESTING AND DEDUCTIONS: A deduction of [U] two-tenths of one percent (0.2%) will be made to cover evaporation and other normal losses during transportation.
