Cost of Gas	<p>DEFINITIONS AND ADJUSTMENTS: Gas Cost Adjustment. The Base Rate per MCF shall be adjusted upward (downward) when the Company's weighted average cost of gas purchased for resale is more (less) than \$2.25 per MCF. The Company's monthly weighted average cost of gas per MCF shall be computed to the nearest cent (\$0.01), and the Gas Cost Adjustment per MCF shall be applied to each MCF billed. Lost and unaccounted for gas (LUG) expense shall be allowed at the rate of five percent (5%) or the Company's actual LUG, whichever is smaller. The monthly adjustment shall be computed as follows when the weighted average cost of gas is known: <math>A = (C - \\$2.25) (1 + (LUG))</math> Where: A = The amount of the monthly adjustment. C = The Company's current weighted average cost of gas purchased for resale. P = The volume of gas purchased during the most recent 12-month period ended June 30. S = The volume of gas sold during the most recent 12-month period ended June 30. LUG = Lost and unaccounted for gas is 0.05 or (P-S)/P, whichever is smaller. The Commodity Rate shall be adjusted each month as provided in the Gas Cost Adjustment. Payment	The above net monthly rate, as adjusted, increased by 5% is the gross monthly rate. All bills shall be delinquent unless payment is received within fifteen (15) days from the date of the bill. All bills shall be rendered on the gross basis. The difference between the gross and net rates, representing a discount, shall be allowed for payment of bills received within 10 days from the date of the bill.
RiderRCR_Montgomery	A monthly surcharge in the amount of 0.4101 per Mcf for relocation costs has been approved by the Railroad Commission, effective for volumes on meters read on or after July 20, 2007, for unincorporated gas sales customers in the Montgomery County Service Area.
SFR01012011	The price for all gas delivered each calendar month shall be the sum of the delivering party's total gas cost per thousand cubic feet (MCF) for the delivery month, plus the following sums: First 1,000 MCF \$1.75 per MCF; Next 2,000 MCF \$1.15 per MCF; All Additional Quantities \$0.60 per MCF. Each of the prices set forth above shall escalate at the rate of 3% per year beginning January 1, 2007, and continuing each year thereafter for the term of this agreement. On or before the 10th day of each month, the delivering party shall invoice the receiving party for all gas delivered at each delivery point during the previous calendar month. The receiving party shall pay each invoice in full not later than fifteen days after the receipt of such invoice.
