Progress towards such five year benchmark of 14.5 bcf will be measured every six months against the rate of 1.45 bcf per six month period. If the aggregate quantity of gas received into the system from all sources during any successive six month period (commencing with the first complete month in which deliveries of gas commenced) is less than 1.45 bcf, the initial gathering fee shall be proportionately increased for the next succeeding six month period by the amount required to make up the monetary short fall in the previous six months benchmark; provided, however, in no event will the gathering fee be increased beyond \$.90 per mcf and further, the gathering fee shall be or not be decreased below \$.45 per mcf until the earlier of (1) or (2) mentioned herein occurs. Plus proportionate share of gathering fuel used in the operation of the system, lost and unaccounted for gas, dehydration, treating or tce fees and fuel if any and taxes

Owner shall pay Transporter a low volume fee equal to two hundred fifty dollars (\$250.00) per month for each Receipt Point which the total monthly volume of gas delivered hereunder is less than five hundred(500) MMBtus.
