Variable Charges: In addition to the monthly fixed customer charge,a variable charge for each Mcf used, subject to the minimum monthly variable charges outlined in item 3 below: (a) Years 1-10 of the agreement term, a monthly charge equal to sixty cents (\$0.60) per Mcf on volumes of less than two hundred ninety thousand (290,000) Mcf per year. (b) Years 1-10 of the agreement term, a monthly charge equal to forty-five cents (\$0.45) per Mcf on volumes at or above two hundred ninety thousand (290,000) Mcf per year. 3. Minimum Monthly Variable Charges: The greater of (a) the variable charge times the Mcf usage outlined in item 2 above or (b) the following minimum variable charges: (a) Years 1-10 of the agreement term: One hundred seventy-two thousand dollars (\$172,000) per year. (b) Within sixty (60) days after the anniversary of the date gas is first delivered to the facilities, the difference between the minimum monthly variable charge the variable charges paid during the twelve (12) months covered by that contract year shall be calculated. If the variable charges paid are less than the minimum monthly variable charge, the difference will be billed, and that amount shall be due within thirty (30) days from the date it is billed.
