Note:

- Data for visualizations for the *Approved Drilling Permits and Wells Spudded* will be updated monthly for the previous month. Data visualizations reflect a snapshot in time, as information may change and be updated as the Commission may receive original or revised reports from operators after the monthly information has been updated.
- The coordinate information being provided is in NAD 83 format.

Drilling Permits

- Permit approval numbers are for original filings approved during the selected month.
- Drilling permit locations shown are for the surface location of the well.
- To learn the path of a proposed well that will be directionally drilled, view the permit.

Wells Spudded

- Spud and surface casing information provided is for approved “New Drill” wells.
- The operator of a well must file with the Commission the appropriate completion report within 90 days after completion of the well or within 150 days after the date on which the drilling operation is completed, whichever is earlier.
- Well locations shown are for the surface location of the well.
- To learn the path of a proposed well that will be directionally drilled, view the permit.

- “Spud date” is the date of commencement of drilling operations, as shown on Commission records.
- Spud dates are captured by the operator contacting the Commission and reporting the date operations commenced.
- Spud date information provided is for approved “New Drill” wells.
