**Note 1:** Any shipper that ships greater than [W] 4,500 3,000 barrels per day, on an average basis, during a calendar month ("Qualifying Month") from the Falls City Truck Offload Terminal, the Karnes City Truck Offload Terminal, Karnes County, Texas, or any combination thereof, to the Three Rivers Refinery, Live Oak County, Texas ("Qualifying Shippers") will qualify for the following temporary volume incentive rate. For all movements by Qualifying Shippers from the Falls City Truck Offload Terminal or the Karnes City Truck Offload Terminal during the Qualifying Month, a temporary volume incentive rate of [I] 62.84 cents per barrel will apply. Carrier notes that the volume incentive rate set forth in this Note 1 is available for a limited period and may be cancelled by Carrier at any time.

**Note 2:** Committed Shippers with an effective transportation service agreement expiring December 31, 2027 ("Committed Shippers") will be charged a rate of [I] 115.42 cents per barrel for all movements under this tariff from Karnes City Truck Offload Terminal, Karnes County, Texas. Such Committed Shippers will not be eligible for the incentive rate contemplated in Note 1 of this tariff.

**Note 3**: This rate will be effective for all movements that were delivered on or after July 1, 2022, in accordance with the terms of the Committed Shipper's TSA.

**UNLOADING CHARGE:** All shipments unloaded by tank truck into the mainline facilities will be subject to a charge of [I] ten and ninety-five hundredths cents (\$0.1095) per barrel in addition to the transportation rates named herein.
