GATHERING CHARGES

For gathering charges into Reception Points above, see Centurion Pipeline L.P.'s Local Tariff Texas R.R.C. No. 13, or reissues thereof.

HANDLING, PUMPING, AND DELIVERY CHARGE – An additional charge of [I] seven and ~~twenty-nine~~ seventy-nine one-hundredths cents (~~7.29¢~~ 7.79¢) per barrel will be made for delivery of crude petroleum through Carrier's system for injection into Plains Basin Pipeline or Enterprise Pipeline at Midland Tank Farm, Midland County, Texas for further movement to other destinations. For delivery of crude petroleum through Carrier's system for injection into Plains Pipeline L.P. to Mesa Pipeline Station's common manifold and further delivery to Mesa Pipeline or to Plains Pipeline Midland Stations at Midland Tank Farm, Midland County, Texas for further movement to other destinations, T.R.R.C. Tariff No. 10, supplements thereto and reissues thereof, will apply.

TRUCK HANDLING CHARGE – An additional charge of [U] five and no cents (5.00¢) per barrel will be charged for truck receipts made into Andrews Station [Andrews] Andrews County, Texas, Hockley County, Texas, Mallet Station [Mallet], Hockley County, Texas, Seminole Station [Seminole], Gaines County, Texas, and Fullerton Station [Andrews], Andrews County, Texas. Truck receipts at these locations will be subject to the TRUCK HANDLING CHARGE in addition to the trunk line rates from the origins defined above in the brackets.
