1. **[W] ET-S Permian Pipeline Company LLC ETP-Crude LLC – From Points of Origin, Reeves County, Texas to Barstow, Ward County, Texas; and**
2. **Plains Oryx Permian Basin Pipeline LLC– From Barstow, Ward County, Texas to Basin Pipeline Hendrick Station, Winkler County, Texas**

RATE A: The joint tariff anchor rate is available to any Shipper for the transportation of crude oil produced from acreage that is dedicated on Phase I, prior to August 1, 2012, to shipment on the pipeline pursuant to a fully executed Dedication Agreement with **[W] ET-S Permian Pipeline Company LLC ETP-Crude LLC**, successor to RHEP Crude LLC and Hoover Energy Texas Crude LLC.

RATE B: The joint tariff dedication rate is available to any Shipper for the transportation of crude oil produced from acreage that is dedicated, subsequent to August 1, 2012, for Phase I, and subsequent to August 30, 2013, for Phase II, to shipment on the pipeline pursuant to a fully executed Dedication Agreement with **[W] ET-S Permian Pipeline Company LLC ETP-Crude LLC**, successor to RHEP Crude LLC and Hoover Energy Texas Crude LLC with a minimum of 10,000 acres for a minimum term of five years.

RATE C: The joint tariff anchor rate is available to any Shipper for the transportation of crude oil produced from acreage that is dedicated on Phase II, between August 1, 2013 and August 30, 2013, to shipment on the pipeline pursuant to a fully executed Dedication Agreement with **[W] ET-S Permian Pipeline Company LLC ETP-Crude LLC**, successor to RHEP Crude LLC and Hoover Energy Texas Crude LLC.

PUMPING CHARGE: There will be no pumpover charge for barrels delivered at Hendrick Station, Winkler County.

Exceptions to the Rules and Regulations Tariff:**Section 2-Explanation of Terms and Abbreviations will be supplemented and amended as follows:**

"Dedication Agreement" as herein used means a connection and dedication agreement or a tank lease agreement that provides for the commitment of resources to **[W]** ET-S Permian Pipeline Company LLC ~~ETP Crude LLC~~.

"Nomination Date" as herein used means the the fifteenth (15th) of the month preceding the movement, as adjusted for weekends and Carrier Holidays pursuant to Rule 30(c).

Rules 30(c) and 30(d)- In lieu of the nomination due date contained in Rules 30(c) and 30(d) of the Rules and Regulations Tariff, the following will apply: nominations to the Carrier shall be made before 12:00 noon Central Standard Time/Central Daylight Saving Time, whichever is applicable, on the fifteenth (15th) of the month preceding the movement, as adjusted for weekends and Carrier Holidays pursuant to Rules 30(c) and 30(d).

Rule 31 E – Measurements and Adjustments will be supplemented as follows:

The gravity adjustment in Rule 31 E will be calculated on the common stream gravity of Crude Petroleum delivered by **[W]** ET-S Permian Pipeline Company LLC ~~ETP Crude LLC~~ and received by Plains Oryx Permian Basin Pipeline LLC at Barstow, Ward County, Texas.
