Except as otherwise expressly provided herein, the rates published in this tariff and the services hereunder are governed by the Rules and Regulations published in ExxonMobil Pipeline Company's currently effective Texas Intrastate No. 208, with respect to that portion of the transportation services provided by ExxonMobil Pipeline Company and Magellan Pipeline Company, L.P.'s (MPL's) currently effective Texas No 49, with respect to that portion of the transportation services provided by Magellan Pipeline Company, L.P. (respectively, the "ExxonMobil Rules" and the "Magellan Rules"). Any conflicts between the terms of the Magellan Rules and the ExxonMobil Rules with respect to the entirety of the joint pipeline transportation governed by this Tariff shall be resolved in favor of the governed by the applicable provision of the Magellan Rules.
