- 5. My Organization: This displays information about your organization including officers, specialty/activity codes, wells, financial assurance, contact information, etc.



For an Org Admin / Delegated Admin to grant filing rights to themselves or other users:

- Login to LoneSTAR under the context of the Organization you wish to edit.
- Under the My Organization tab, go to the Other People section.
- Click on the user's name to go to the person detail page.
- Click on the Summary dropdown button and select Security.
- Check the boxes for the desired filing rights.
- Click Save.
