* Anchor Shippers as defined in the Rules and Regulations Tariff, Texas R.R.C. No. [W] ~~2.1~~, of Carrier shall instead be charged an incentive rate [C] ~~of \$0.40820 per Barrel~~ for providing the economic support for the initial construction of Carrier’s facilities.

Additional Fees:

Lost and Unaccounted For Allowance: For Anchor Shippers, Condensate will be measured at the Delivery Point(s) and Anchor Shipper shall bear all losses through normal operations in the movement of Anchor Shipper’s Condensate from the Receipt Points to the Delivery point(s). For all other Shippers, each Shipper shall bear losses in proportion to its total quantities tendered at the Receipt Point(s).

Pumping Charge: Where pumping service is performed by Carrier an additional charge of [I] \$0.5307 per barrel will be made on all condensate pumped directly into another carrier’s system. The Pumping Charge for Anchor Shippers is included in the rate set forth above.

Hand Run Gauging Fee: There will be an additional charge of [I] \$1.0611 per barrel on gathered condensate which is hand run gauged. The Hand Run Gauging Fee for Anchor Shippers is included in the rate set forth above.

Rate escalation:

The rates set forth in this Tariff shall be adjusted by Carrier beginning on January 1st of 2013 and each January 1st thereafter (the "Rate Escalation Date") in accordance with the following formula:

$$\{[(A/B - 1) * 0.5] * C\} + C = \text{adjusted rate}$$

Where

A = the Consumer Price Index, All Urban Consumers, U. S. City Average, All Items, as published by the U. S. Department of Labor, Bureau of Labor Statistics (CPI-U) or its most comparable successor for the Month of December of the year immediately preceding the Rate Escalation Date

B = the CPI-U for the month of January of the year immediately, preceding the Rate Escalation Date

C = then-current rate that is subject to adjustment hereunder

Notwithstanding anything herein to the contrary, such adjustment shall not reduce such rates below the amounts originally set forth for the same in the Texas R.R.C. No. 1 Local Tariff originally filed by Carrier with the Railroad Commission of Texas.
