NOTES APPLICABLE TO TABLES OF RATES

"TBD," as used in this tariff, shall mean to be determined by contractual agreements based on market conditions and circumstances existing at the time of agreement.

[W] Exceptions to the Rules and Regulations Tariff:

Rule 9: In lieu of the pipeline loss allowance set forth in Rule 9 of the Rules and Regulations Tariff, the following loss allowance shall apply to movements under the rates set forth herein:

- a. For Crude Petroleum transported under Rate A Transportation, there will be a loss allowance of one-tenth of one percent (0.1%).
- b. For Crude Petroleum transported under Rate B Transportation, there will be a loss allowance of two-tenths of one percent (0.2%).

For Crude Petroleum transported under the Gathering Rates set forth herein, any gains and losses will be apportioned to Shippers on a monthly basis in proportion to each Shipper's movements on the pipeline during the calendar month.

[N] Special Rule 17(B): In lieu of the charge basis set forth in Special Rule 17(B) of the Rules and Regulations Tariff, for Crude Petroleum transported under the Gathering Rates set forth herein, Shipper shall pay all transportation and other fees and lawful charges accruing on Crude Petroleum delivered to and accepted by Carrier for shipment as measured at the Origin points. For Crude Petroleum transported under the Transportation Rates set forth herein, Shipper shall pay all transportation and other fees and lawful charges accruing on Crude Petroleum delivered at the Destination/Delivery points.
