Truck Unloading Charge: Crude petroleum unloaded from tank trucks into Carrier's facilities will be subject to a [C] 2.43 cent per barrel unloading charge.

Pumpover Charge: Where pumping service is performed by Plains Pipeline, L.P., an additional charge of [C] 12.24 cents per barrel will be made on all crude petroleum pumped to Phillips 66 Odessa Station in the Goldsmith area.

Exceptions to Plains Pipeline, L.P.'s Rules and Regulations Tariff:

Rules 25(c) and 25(d) - In lieu of the nomination due date contained in Rules 25(c) and 25(d) of Plains Pipeline, L.P.'s Rules and Regulations Tariff, the following will apply: nominations to the Carrier shall be made before 12:00 noon Central Standard Time/Central Daylight Saving Time, whichever is applicable, on the fifteenth (15th) of the month preceding the movement, as adjusted for weekends and Carrier Holidays pursuant to Rules 25(c) and 25(d).

Rule 80 - In lieu of the 0.2% loss allowance deduction stated in Rule 80 of Plains Pipeline, L.P.'s Rules and Regulations Tariff, the following loss allowance deduction will apply: no loss allowance.
