When movements under this tariff occur on Gray Oak Pipeline, LLC's system, such movements will be governed by the Rules and Regulations set forth in Gray Oak's Texas Tariff No. 1.7 and reissues thereof.

Arrowhead Eagle Ford Pipeline, LLC and Gray Oak Pipeline, LLC are the owners of their respective portions of the pipeline segments that comprise the joint movements set forth in this tariff. The local movements and associate rates of each carrier for the joint movements listed herein are available in Arrowhead Eagle Ford Pipeline, LLC’s Texas Tariff No. 2.36 and Gray Oak Pipeline, LLC’s Texas Tariff No. 3.19, and successive reissues thereof.

Notes to Table

Note 1: The Committed Shipper Rates are applicable to any Shipper that has an effective transportation services agreement with Arrowhead Eagle Ford Pipeline, LLC, wherein the Shipper has agreed to ship, or otherwise pay for, a minimum volume of crude petroleum from one of the origin points to the destination point in this tariff, over a one-year period.

Note 2: The Uncommitted Shipper Rates apply to any Shipper that is not a Committed Shipper.

Note 3: Any shipper that enters into a Transportation Services Agreement with Carrier and agrees therein either to (i) ship or otherwise pay Carrier for failing to ship a specified volume of crude oil or (ii) dedicates certain production for delivery to Carrier’s system, in each case, for a period of at least one year, may qualify for a Committed Shipper Rate for the movement. Interested shippers should contact Carrier for more information.

UNLOADING CHARGE: All shipments unloaded by tank truck into the mainline facilities under this Arrowhead/Gray Oak Joint Tariff No. 1.1 will be subject to a charge of [I] ten and ninety-eight hundredths cents (\$0.1098) per barrel in addition to the transportation rates named herein.
